GENERAL TERMS & CONDITIONS (Please make a copy for your records.)

1. **Defined Terms:** The term "Event" means The Rochester Collectible & Vintage Toy Show, scheduled to be held on **Sunday, June 9, 2019** ("Event Date") between 10am and 3pm at **Bill Gray's Regional Iceplex** located at **2700 Brighton Henrietta Townline Road in Henrietta, New York** ("Exhibit Facility"). Load-in and set-up is scheduled for Saturday, June 8, between Noon and 4pm AND Sunday, June 9, between 7am and 10am ("Set-up Hours") The Event is owned, produced and managed by Rochester Collectible & Vintage Toy Show ("RCVTS"). As used hereinafter, the term "Organizer" means, collectively, RCVTS, and each of its respective officers, directors, agents, affiliates, representatives, and assigns. The term "Exhibitor" means collectively, the person or business entity that applied for exhibit space and any of its respective personnel that assist the Exhibitor in connection with the Event.

2. **Assumption of Risks; Releases; Limitation of Liability:** Exhibitor expressly assumes all risks associated with, resulting from or arising in connection with Exhibitor's participation at the Event, including, without limitation, all risks of theft, loss, harm, damage or injury to the person (including death), property, business or profits of Exhibitor, whether caused by negligence, intentional act, accident, act of God or otherwise. Exhibitor has sole responsibility for its property or any theft, damage or other loss to such property. Organizer makes no representations or warranties, express or implied, including the number of persons who will attend the Event or regarding any other matters.

3. **Exhibit Items:** RCVTS reserves the right to require Exhibitor to remove any items from Exhibitor's space that RCVTS determines to be inconsistent with the theme of the Event. Exhibitor may not block aisles or walkways.

4. **Exhibitor Personnel; ID Badges and/or Bracelets:** Exhibitor may bring 1 (one) helper to assist them during Set-up Hours and the Event. Any additional helpers must purchase an Early Buyer Pass to access the venue. Exhibitor and its personnel must check in at the RCVYS registration table prior to loading in or setting up Exhibitor's space in order to receive an ID badge or bracelet for access to the Exhibit Facility. Exhibitor and its personnel must wear their ID badge or bracelet at all times while on-site at the Exhibit Facility.

5. **Exhibitor Space:** As long as Exhibitor's application is received no later than **May 10, 2019**, RCVTS will try its best to honor Exhibitor's previous table placement. Exhibit space shall be assigned by RCVTS at its sole discretion. RCVTS reserves the right to change the floor plan or to move an Exhibitor to another location within the Exhibit Facility prior to or during the Event if RCVTS determines that to do so is in the best interest of the Event. Exhibitor shall only use table(s) provided by RCVTS that Exhibitor requested. **Tables provided will be 8-feet long.** Exhibitor may not add any additional display tables to its contracted space. Exhibitor may not move or reconfigure its assigned tables. If Exhibitor fails to set up its display in its assigned space by one hour before show opens or leaves its space unattended during the Exhibit hours, RCVTS shall have the right to take possession of the space and no refund will be due to Exhibitor. All exhibits must be open for business during the Event hours. **Exhibitor may not dismantle the display until the Event is officially closed by RCVTS.** Exhibitors may not assign or sublet their display space to third parties without prior approval from RCVTS.

6. **Cancellation by Exhibitor:** There will be no refunds for cancellations made by Exhibitor less than 14 days prior to the Event Date.

7. **Cancellation of the Event:** If RCVTS cancels the Event due to circumstances beyond its reasonable control (such as acts of God, acts of war, governmental emergency, labor strike or unavailability of the Exhibit Facility), RCVTS shall refund to each Exhibitor its exhibit space rental payment previously paid, minus a share of costs and expenses incurred, in full satisfaction of Organizer's liabilities to Exhibitor.

8. **Taxes and Licenses:** Exhibitor shall obtain any licenses, permits or approvals under federal, state or local law applicable to its activities at the Event. Exhibitor shall obtain any necessary tax identification numbers and permits and for paying all taxes, license fees, use fees, or other fees, charges, levies or penalties that become due to any governmental authority in connection with its activities at the Event.
